SUMMARY DESCRIPTION

This new MA in Playwriting has the ambition to offer the very best aspiring playwrights excellent training for them to become the most exceptional professional playwrights they can be.

You will study past playwrights, contemporary playwrights, and begin the journey of finding what is unique about your own voice to forge a path as a playwright of the future.

The course will also offer integration with other RADA students studying acting, technical, stage management, and costume. You will be taught via a range of masterclasses, workshops, seminars, readings, one-on-one feedback sessions, guest speakers, and the development of a strategic career plan. You will also study transferable skills in relation to musical theatre, adaptation, film, TV, and audio drama. The course will also include theatre trips, and prioritise an understanding of access, diversity, and inclusion.

Learning and teaching methods

This is a vocational MA, so the emphasis on this programme will be on learning by doing. You will write two plays; a one act play for a showcase reading and the first draft of a full-length play for submission to professional production companies. Seminar study, reading, and report writing will also

be supplemented by practical playwriting workshops. One-to-one tuition will be largely focussed on your original writing. Guest speakers, and theatre visits will all be designed to enhance your professional knowledge.

Classes will mainly take place bi-weekly and will include one evening weekday and Saturday sessions.

The rehearsal and showcase process may require your attendance as per the production schedule which could be up to six days a week which would include daytime and evening sessions.

Detailed termly timetables will be provided which are subject to change for instances for theatre visits and professional development guest lectures.

ASSESSMENT

Overview

Formative assessment will be through attendance and continuous assessment of contribution to classes, discussions, workshops, readings, seminars, and rehearsals.

Summative assessment will be through submission of written reports on set reading, writing exercises, a *Vision Statement*, a *Strategic Career Plan*, an original one-act play, the showcase reading of your one act play, and the first draft of a full-length play.

What do I have to do to pass?

In order to pass the programme, you must pass each module with an overall mark of 50.

There is no provision for condonement for any modules, awards

This programme can lead to one of three awards:

On successful completion of 60 credits at level 7, the Postgraduate Certificate (PgCert)

On successful completion of 120 credits at level 7, the Postgraduate Diploma (PgD)

On successful completion of 180 credits at level 7, the Master of Arts (MA)

ADMISSIONS CRITERIA

Applicants for this programme are expected to hold a degree qualification (2.2 or above) or equivalent qualification in a related subject or discipline, and/or be able to demonstrate professional or practical experience at a level commensurate with Master's level study.

Applicants will be asked to demonstrate their suitability for the course based on previous education, qualifications held and/or experience.

All applicants must submit a portfolio of original dramatic writing of about 40 minutes playing time – approximately 35-40 pages. This can be a one-act play, a section from a full-length play, or extracts from more than one work. Extracts from the book for a musical, an adaptation, screen or audio drama can also be included, but only as extracts accompanying a longer piece of original writing for the stage.

Applicants whose portfolio is judged to be of suitable potential will be invited for interview
